**HOW TO  
APPLY**

1. Application for MIS can be accessed on our online application system via the link  
**<https://biasiswa.mohe.gov.my/INTER/index.php>**
2. Applicants will have to provide all the necessary information and have the compulsory documents listed below **scanned and saved in PDF format** and later uploaded to the online application system:
  - i. Application Form;
  - ii. A certified copy of Passport as evidence of nationality (with minimum validity of **6 months**);
  - iii. A certified copy of Academic Transcript(s):
    - a. Transcripts of undergraduate studies (additional of Master's degree transcript for PhD applicants)
    - b. Reflect the record of all the courses taken throughout the previous study programme(s)
    - c. Must be submitted together with **a certified official document issued by the applicant's alma mater describing the institution's grade system if the applicant's transcript does not include information on CGPA, marks or score percentile.**
  - iv. A certified copy of English Proficiency test result (IELTS / TOEFL);
  - v. Letter of Recommendation from **two (2) referees**;
  - vi. Endorsement Form;
  - vii. Admission letter from Malaysian university/higher education institute (if applicable);
  - viii. Curriculum Vitae; *and*
  - ix. Research Proposal

***\*the documents are to be scanned and saved in PDF format before being uploaded to the online application system***

<p><b>ELIGIBILITY CRITERIA</b></p>	<p>Applicants must fulfill the following criteria for their applications to be considered further:</p> <ol style="list-style-type: none"> <li>1. Is not more than 40 and 45 years old at the time of application for Master and PhD levels respectively</li> <li>2. Possessing good academic qualifications: <ol style="list-style-type: none"> <li>i. Masters applicants: obtaining <b>CGPA 3.0 / 2nd Class Upper (Honours)</b> or higher at Bachelor's Degree level;</li> <li>ii. PhD applicants: obtaining <b>CGPA 3.0 / excellent results at Masters</b> level in course related to the intended study program</li> </ol> </li> <li>3. Mastering good proficiency of English Language: <ol style="list-style-type: none"> <li>i. Obtaining <b>band 6.0 or higher in IELTS</b>; <i>or</i></li> <li>ii. Obtaining a <b>total score of 550 or higher in TOEFL</b> paper-based test (PBT); <i>or</i></li> <li>iii. Has obtained previous degree(s) with English used as the medium of instructions (evidence is a prerequisite).</li> </ol> </li> <li>4. Submitting a written research proposal with minimum of <b>1,000 words</b> that is relevant to the intended field of studies.</li> </ol>

Successful applicants are expected to independently arrange their travel to Malaysia (non-financial provisions). Travel expenses will not be provided by the Government of Malaysia.</li> <li>3. All applicants are highly advised to check the expected living expenses in Malaysia.</li> </ol>

<p><b>AREAS OF STUDY</b></p>	<p>Applicants are welcome to apply for any accredited courses with priorities given to courses under the following areas of study:</p> <ol style="list-style-type: none"> <li>1. Education</li> <li>2. Arts and Humanities</li> <li>3. Social Sciences, Journalism and Information</li> <li>4. Business, Administration and Law</li> <li>5. Natural Sciences, Mathematics and Statistics</li> <li>6. Information and Communication Technologies</li> <li>7. Engineering, Manufacturing and Construction</li> <li>8. Agriculture, Forestry, Fisheries and Veterinary</li> <li>9. Health and Welfare <i>*not including medicine, nursing and pharmacy</i></li> </ol>
<p><b>SELECTION CRITERIA</b></p>	<p>Applications will be considered according to the following selection criteria:</p> <ol style="list-style-type: none"> <li>1. Outstanding academic achievement.</li> <li>2. The quality of the research proposal and its potential contribution towards advancement of technology and human well-being.</li> <li>3. Excellent communication, writing and reading skills in English Language.</li> </ol>
<p><b>TERMS AND CONDITION</b></p>	<ol style="list-style-type: none"> <li>1. Scholars must undertake full-time study for postgraduate programs at the selected universities and higher education institutes. It is the responsibility of the scholars to confirm their admission to the university.</li> <li>2. Scholars must not change their study program during the tenure of the scholarship except with written permission from the university and the Ministry of Higher Education.</li> <li>3. Scholars must fulfill the requirements of the study program and abide by Malaysia's laws and the university's rules, regulations and codes of conduct.</li> <li>4. Any suspension from the university will result in the scholar's immediate suspension of the scholarship. Monthly allowances are not payable during the suspension.</li> </ol>

	<p>5. It is the responsibility of the successful candidates to apply and meet the requirements for the issuing of an appropriate entry visa including a medical examination. The offer of the scholarship does not guarantee the granting of a visa. Scholars must maintain satisfactory academic progress and good standing throughout the study duration as stipulated by their host university, failure of which will result in the scholarship being withdrawn.</p> <p>7. The scholarships are tenable in Malaysian universities and higher education institutes and research must be carried out in Malaysia.</p> <p>8. Scholars are not allowed to take any paid employment during their tenure unless with written approval from the host university.</p>
